



# **METANIA GAMES PRIVACY POLICY**

**Effective Date:** June 30, 2022

## **1. Intro**

As Metania Games Limited Şirketi, (“Metania Games” or “we”, “us”) we are a crypto assets investment and technology company that designs and develops games. With this Privacy Policy, we aim to transparently explain how and why we gather, store, share and use your personal data in a manner consistent with the laws of the countries in which we do business. Your privacy and the security of your personal data is, and will always be, enormously important to us. Where this Policy refers to "personal data" it is referring to any information that relates to an identified or identifiable living individual.

This Privacy Policy applies to websites, mobile applications, forums and every kind of blogs of Metania Games and any other online or offline services provided by Metania Games. It also applies to our marketing and advertising activities on all platforms and other services that we may provide to you from time to time. In this Privacy Policy we refer to our games, assets(token), websites, marketing and advertising activities and other services collectively as our "Services".

Under this Privacy Policy, your personal data shall be processed in order to provide the Services once you download our mobile application, access and/or play our games, assets or interact with our websites or other Services. If you have any other concerns about providing data to us or it being used as described in this Privacy Policy you should not use our games or other Services. This Privacy Policy is intended to meet requirements globally, including those in North America, Europe, Turkey, Asia-Pacific countries and other jurisdictions.

## **2. How We Collect Your Personal Data**

We may collect personal data directly from you or other third-party companies who have obtained your consent or have another legal right to share such personal with us (including advertising platforms and partners and data aggregators who have obtained). This may include attributes about you and your interests, as well as other games and services you use, demographic and general location information. We will use your personal data as described in this Privacy Policy.

Metania Games processes your personal data in order to provide the Services by downloading, accessing and/or playing our games or using our other Services. Most of this data comes directly from you or your device, such as your unique device ID (persistent/non-persistent), your device operating system, version, model, CPU, amount of RAM and disk space, hardware type, Identifier For Advertising (IDFA), advertising ID, the version of your operating system ("OS"), cold or hot wallet address, and your location based on your Internet Protocol ("IP"). We use this data to provide our games and Services to you, including for the purposes of optimization, customizing and in-game offers and verifying purchases. We may also use it for the other purposes set out in this Privacy Policy.



Depending on which of our Services you interact with we may collect and process the following types of information:

- details about how you use and interact with our games and assets, advertising and other Services (for example, information about how and when you play our games or visit our website(s), what device you use to access our games and Services or details regarding profile visits;
- your interactions with us on our social media channels.
- Information about plugins you might be using, included but not limited to those related to the management of cryptocurrency assets and any information provided by them.

### **3. What Is Done With Your Information**

Your information may be used in the following ways:

- To analyze trends for how the Site and Tools are being used;
- To improve the Site and the Tools;
- To help personalize your experience of the Site and the Tools; and
- If you provide your contact information, you may receive technical notices, updates, confirmations, security alerts, to provide support to you, to tell you about other products and services that might interest you, or to respond to your comments or questions.

Your personal information may be disclosed to agents, businesses, or service providers who process your personal information for providing the Site and the Tools to you. The agreements with these service providers limit the kinds of information they can use or process and ensure they use reasonable efforts to keep your personal information secure.

Metania Games undertakes to keep your data and any confidential information strictly private and confidential, without prejudice to the contents hereof, to regard it as an obligation to keep confidentiality, to take all measures and act in due diligence to prevent all or any part of your information from entering into the public domain or be subject to unauthorized use, or to take measures to prevent the confidential information from disclosure to any third party. If, despite all necessary data security measures taken by Metania, the confidential information is damaged as a result of attacks on the system or captured by third parties, Metania shall have no responsibility with that respect.

### **4. Disclosure Data**

Legal Requirements Metania Games may disclose your Personal Data in the good faith belief that such action is necessary to:



To comply with a legal obligation To protect and defend the rights or property of Metania Games to prevent or investigate possible wrongdoing in connection with the Service To protect the personal safety of users of the Service or the public To protect against legal liability

*Security of Data* The security of your data is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

## 5. Your Rights

- Subject to applicable law, you may have some or all of the following rights in respect of your personal information:
- to obtain a copy of your personal information together with information about how and on what basis that personal information is processed;
- to rectify inaccurate personal information (including the right to have incomplete personal information completed);
- to erase your personal information (in limited circumstances, where it is no longer necessary in relation to the purposes for which it was collected or processed);
- to restrict processing of your personal information where: **a.** the accuracy of the personal information is contested; **b.** the processing is unlawful but you object to the erasure of the personal information; or **c.** we no longer require the personal information but it is still required for the establishment, exercise or defense of a legal claim;
- to challenge processing which we have justified on the basis of a legitimate interest (as opposed to your consent, or to perform a contract with you);
- to prevent us from sending you direct marketing;
- to withdraw your consent to our processing of your personal information (where that processing is based on your consent);
- to object to decisions which are based solely on automated processing or profiling;
- in addition to the above, you have the right to file a complaint with the supervisory authority.
